

Release of Liability, Waiver of Claims and Indemnity Agreement:
Graduation Trip 22Js INSEAD Effective Date 01/04/2022

This agreement is made and entered between the CHAB Pte Ltd further referred to as "[Organizer]", located at 59 avenue Franklin D. Roosevelt, 75008, Paris and the participant further referred to as "[Participant]"

- 1) [Organizer] reserves the right to remove any person from the event who does not carry a valid wristband for the parties.
- 2) Force Majeure. Neither party shall not be in default or otherwise liable for any delay in a failure of its performance under this agreement where such delay or failure of its performance under this agreement arises by reason of an Act of God, or any government, acts of war, the elements, strikes or labour disputes or other causes beyond the control of the party.
- 3) Copyrights: The company requires to publish a small selection of pictures on its official social media accounts. The pictures will be chosen and validated by the Grad Trip Committee before publication.
- 4) I, hereby affirm and acknowledge that I fully understand the hazards and risks associated with the many outdoor and other recreational activities in which I am about to engage on the Graduation Trip 22Js. The inherent risks and hazards include but are not limited to:
 - Injuries sustained from any and all outdoor activities, such as running, jumping, hiking, biking, climbing, camping, cooking, engaging in sporting events such as basketball, volleyball and more.
 - Injuries sustained from objects that are either natural or man-made, such as rocks, cliffs, trees and campfires, or from misjudging trails or other terrains that induce slipping, falling, colliding or otherwise.
 - Injuries and illnesses sustained from swimming, diving, scuba diving, cliff jumping, boating, impacting the water, and/or water entering bodily orifices.
 - Injuries from hypothermia, heat stroke, dehydration, etc. from exposure to the elements, such as rain, cold, excessive heat or the weather in general.
 - Physical and monetary injuries sustained due to my own personal negligence and/or the negligence of others, crowds, altercations with other patrons, the excessive use of alcohol, the prohibited use of illegal drugs, and the like.
 - Injuries or illnesses sustained from either plants or animals, such as poison ivy, poison oak, poison sumac, aggressive or biting pets, service animals, wildlife, or exposure to any plants or animals present within the park in general.
 - Accidents, injuries or illnesses, including pandemic and COVID-19 occurring in remote locations where no immediate medical attention is available. I understand that the description of these risks is in no way complete and that all such dangers, both anticipated and unanticipated, can lead to illness, injury, permanent disability, drowning and death.

In making it possible to participate in many of the above-described activities and more, I both agree and acknowledge that:

- 5) I hereby release and hold harmless with respect to any and all illness, injury, disability, death, or loss or damage to person or property—whether caused by negligence or otherwise—the following named persons or entities, herein referred to as Releasee’s: Chab Private Limited.

- 6) I hereby agree that all damages caused by a group of participants of the trip where no clear offender can be identified will be split evenly across the group.

- 7) I hereby release the Releasee’s, their officers, directors, managers, employees, representatives, agents, volunteers, and other vessels from any and all liability and responsibility and for any claims that I, my estate, heirs, survivors, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of the Releasee’s or otherwise. By executing this document, I agree to hold the Releases harmless and indemnify them in conjunction with regard to any illness, injury, disability, death, or loss or damage to my own personal property that can ensue from engagement in the full body of activities as stated above and otherwise.

- 8) I hereby release the releasees from any claims relating to personal expenses incurred in the booking or attendance of this trip.

- 9) By entering into this agreement, I am not relying on any oral or written representation or statements made by the releasees other than that set forth in this agreement.
